Directions: From I-5 southbound, Exit 2nd Central Point Exit and follow directions to highway 62 Northbound. Exit Hwy. 62 (right turn) onto Royal Ave. Follow Royal Ave. thru Eagle Point. Royal Ave becomes Brownsborough Hwy. Stay on this road until you are out of Eagle Point and come to a Y. At the Y. Take the left fork which is Brophy Rd. Follow Brophy Rd to the second Y. Take the right fork which is Worthington Rd. This road goes down a steep gully and up. We are at the top of the gully on the right. Parking will be designated. Overnight parking permitted (no hookups).
